- No Assignment. Customer shall not assign all or any part of this Agreement without the prior written consent of MMI.
- <u>Severability</u>. If any provision of this Agreement is held by a court of competent jurisdiction to be invalid, unenforceable, or void, the remainder of this Agreement shall remain in full force and effect.
- Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the Province of British Columbia. The Courts of the Province of British Columbia, and no other court, shall have the exclusive jurisdiction to hear any matter arising in connection with this Agreement.
